#### **Trustees**

**Key point**: Trustees remain legally responsible for their charity and need to be satisfied as to the adequacy of the charity's response to COVID 19

- What should trustees be doing in the current circumstances?
  - Trustee briefings and video calls
  - Impact on services and ability to fulfil charitable purposes
  - Protecting and continuing to support beneficiaries
  - Financial planning and forecasts
  - Practical steps e.g. signing off accounts, executing documents
  - Serious incident reporting



#### **Trustees**

**Key point**: Trustees have a duty to act reasonably and with skill and care

- What should trustees be doing in the current circumstances?
  - Reviewing and updating risk register
  - Review strategy and adapt to meet current need
  - Receive more regular information
  - Document decisions carefully

#### Workforce

- What are the charity specific issues with furloughing?
  - Volunteers
  - Public sector funding (the problems with mix use staff)
  - Employees affected by COVID-19
  - Employment rights and liabilities
  - Decision making and audit trail
  - Apprentices

### Workforce – health and well-being

- Key Point: you have duties as employers to protect and promote the health of your staff.
- Where to focus:
  - Keeping those still working safe and protected
  - Keeping in contact during furloughing (but not working)
  - Mental Health initiatives
  - Continued learning and development time
  - Use of social media and other online resources

### **Operational Matters**

- How are commissioners responding?
  - Tendering suspended
  - Extension of contracts
  - More relaxed regime
  - Document agreements reached
- Other issues
  - Force majeure clauses
  - Waiver
  - Rates relief if no longer using premises?

# **Funding**

- Can members still use your services? Rights to refund?
- What options are there for raising funds?
  - Gift Aid on donations from cancelled events
  - Communication and transparency
  - Duty to consider alternative forms of fundraising
  - Additional safeguards around collection of funds

- The situation remains challenging and uncertain.
- Trustees should:
  - act reasonably, make informed decisions and document them carefully.
  - keep abreast of sector wide guidance
  - seek advice if they are unsure about how to best fulfil their duties
