

The impact is being felt across the construction, real estate, regulatory, financing, and insurance sectors. All stakeholders are affected, whether they are developers, contractors, consultants, owners, landlords, tenants, funders, insurers, or the many other interested parties in these areas.

## Construction and Engineering

Our Construction and Engineering Team is one of the largest full-service construction and engineering teams in the sector, offering our clients both transactional and disputes services. Building safety has been high on their radar since 2017, as has (building) information management and innovation (including modern methods of construction) both of which are affected by building safety.

The changes facing the construction industry are allpervasive, with the Building Safety Act 2022 coming into force, the periods of liability for some claims extending from 6 to 30 years retrospectively, and the introduction of a raft of Regulations, including on higher risk buildings (HRBs), registration of HRBs, the extension and strengthening of the building control regime, and the introduction of key building information. New overseeing bodies have been created in the form of the Building Safety Regulator, Construction Products Regulator, and New Homes Ombudsman. And key challenges for the industry lie in the new Golden Thread, Gateways, Dutyholder regime, second staircases, and construction products rules, all of which will impact the sector significantly.

#### How the team can help

Ways in which the team can assist clients include:

- Advice and guidance of the limitations imposed by the Building Safety Act 2022 (BSA 2022), and the practical effect this may have on the planning, construction and certification stages of projects and constraints on the sales environment
- Legal, contractual and commercial advice when acquiring or disposing of a Higher Risk Building (HRB) or 11m to 18m buildings and developing strategies that provide protection. By way of example, this might include:
